The day-long workshop was held in 2 batches at Ukhiya Relief Operation Center and Camp 14. Member of Cox's Bazar Upazila Parishad was present as invited guest. The following discussion were highlighted by invited speakers and training facilitators.

Story of Hasan & Husan

They are growing up under the care of their grandmother

Orphaned and helpless Hasan and Husan both are twin brothers. Their mother's name is Arefa Begum and their father's name is Md Zubair. Both are born in Camp 15 on 01-01-2019. After 8 days of birth, their mother died due to childbirth. But due to their father's second marriage, they were left with their Grandmother home in A-1 block of

Camp-14. Jamalida faced many difficulties in bringing them up. They experience loneliness due to childhood events that make them not easy to socialize with. As a result, their physical and mental development has not been done properly. Salma Jahan, mentor of the project came to know about the matter through the concerned and met their grandmother along with Arefa Begum, facilitator of Circle ECD Center. During the conversation, Jamalida said that she was facing various difficulties with them. As she was unable to ensure their care and protection, she was depressed. Children were always upset and did not behave like normal children due to lack of parental contact. It should be noted that COAST Foundation is working for the mental & physical development of children aged 3-5 years through 50 ECD centers in different camps of Camp-14. Representative Salma Jahan spoke to Hasan and Husan as their grandmother lives in the project's work area. During the conversation, the COAST representative informed their grandmother about the ECD center and tried to explain that she would be relieved of a lot of stress if the children went to the center. After explaining to her the opportunities for children's development in the ECD center, she agreed to admit the grandsons to the nearest ECD center. On July 17, 2022 they were admitted to the Circle ECD Center.

They are very happy to make new friends as a result of going to the center regularly. They come to the center regularly and socialize with other children. They are growing mentally and physically because of coming to the center and now they are much better than before. Their grandmother Jamalida observed the activities of ECD center and thanked the COAST Foundation for Hasan & Huson's safe and healthy growth.

through 84 LCs and 50 ECD centers in Camp-14. Ensuring student access to each center is among the other equally important tasks of the project. E-2 Block has 4 LCs (Newton, Shakespeare, Meghna, and Plato) in a cluster. About 200 students from different classes are studying in the Newton cluster and the attendance rate is more than 85%. There is a small canal in front of the LC but children could not come to

the center regularly as there was no way to cross it. Due to last year's flood and fragile condition, the old bamboo



bridge collapsed.

Reconstructed the bridge

About 2 months ago the bamboo bridge was damaged due to which students

could not come to LC easily. Parents did not want to send their children to learning centers because they often felt insecure as children got hurt while walking. Hence attendance rate decreased. The SGC and CESG committee members filled the holes in the canal, but after a few days, it returned to the previous situation.

It is our request to rebuild the Bamboo Bridge and pathway during the CESG & parental meeting to overcome this situation. Eventually, the COAST Foundation decided to rebuild the bridge to solve the problem. Children can reach safely the learning center due to the reconstruction of the bridge. At present, the centers have an average attendance of more than 85%. Community people and CESG members thanked COAST for taking up the initiative.
